

Privacy declaration

GENERAL

In this privacy statement you can read everything about the way in which your personal data is collected and how it is handled. This explains where your data is stored and for what purposes your data is stored. In addition, you will also find here your rights with regard to your data and how you can make use of those rights.

The privacy statement will sometimes be changed due to, for example, legislative changes. It is therefore advisable to consult the statement periodically.

COOKIES

If you leave a comment on our site, you can choose to save your name, email address and website in cookies. These are for your convenience so that you don't have to re-enter your details when you leave another comment. These cookies last for one year.

If you have an account and you log in to this site, we will set a temporary cookie to determine whether your browser accepts cookies. This cookie contains no personal data and is deleted when you close your browser.

When you log in, we will also set several cookies to save your login information and your screen display options. Login cookies last for two days and screen options cookies last for a year. If you select "Remember Me", your login will remain for two weeks. If you log out of your account, the login cookies will be deleted.

COMMENTS

When you leave comments on this site, we collect the information shown in the comments form, the visitor's IP address and browser operator string to help spam detection.

An anonymized string created from your email address (also called a hash) may be provided to the Gravatar service to see if you are using it. The privacy policy of the Gravatar service is available here: https://automattic.com/privacy/. After approval of your comment, your profile picture will be visible to the public in the context of your comment.



CONTACT

The moment you contact militex.nl via the contact form or email, the information you send, such as your name, company name and email address, will be stored on the mail server. Mails are stored for a maximum of 7 years.

Militex's email is hosted at Solcon. If you contact us via the registration form or by e-mail, those e-mails will be stored on Solcon's servers. Militex has concluded a processing agreement with Braind and Solcon.

STATISTICS

Militex.nl collects your data to improve the website. This is done with Google Analytics. This data is anonymous and is therefore not linked to your personal data. This includes information such as the duration of your website visit or the pages you visit.
